The meeting was called to order by Mr. Tom Prestash, PennDOT District 9-0. Mr. Chris Allison, Cambria County Planning Commission, polled the members present.

REORGANIZATION: COMMITTEE MEMBER ADJUSTMENTS

Mr. Allison explained that Mr. Imhoff had changed jobs from Planning Commission Executive Director, to Johnstown City Manager, and would therefore be changing roles from the Technical Committee to the Coordinating Committee. Mr. Imhoff's Technical Committee position would be temporarily vacant until a new Planning Commission Director is hired. Mr. Allison noted that Mr. Imhoff was also named as the Vice-Chair for the Technical Committee, and suggested electing a new Vice-Chair. Mr. Imhoff also noted that his Coordinating Committee alternate would be Assistant City Manager Alex Ashcom.

After a brief discussion, the Committee Members decided not to appoint a new Technical Committee Vice-Chair until a new Planning Commission Director was hired. Mr. Rovansek made a motion to appoint Mr. Imhoff to the Coordinating Committee. The motion was seconded by Mr. Pioli and passed unanimously.

APPROVAL OF MINUTES OF THE COMBINED MPO TECHNICAL AND COORDINATING COMMITTEES MEETING OF JANUARY 24, 2022

The committee members reviewed the meeting minutes. Mr. Rovansek made a motion that the minutes be approved. The motion was seconded by Mr. Tusing, and passed unanimously.

REVIEW AND APPROVAL OF AMENDMENTS AND MODIFICATIONS TO THE FFY 2021-2024 HIGHWAY AND BRIDGE TIP

Mr.Prestash presented a list of six projects to be added to the TIP, utilizing \$5.9 million in funds through the Infrastructure Investment and Jobs Act (IIJA). Mr. Imhoff and Mr. Chernisky noted that the project on Washington Street in Johnstown may conflict with a City sewer line project, and also asked if sidewalk rehabilitation was being considered. Mr. Prestash agreed to follow-up on the questions. After a brief discussion, Ms. Lucey-

Noll made a motion to approve the proposed amendments. Seconded by Mr. Rovansek, it passed unanimously.

REVIEW AND APPROVAL OF AMENDMENTS AND MODIFICATIONS TO THE FFY 2021-2024 PUBLIC TRANSIT TIP

Ms. Lucey-Noll stated that there were no amendments requiring a vote. Mr. Prestash moved on to the next agenda item.

REVIEW AND APPROVAL OF THE DRAFT FFY 2023-2026 TIP FOR PUBLIC TRANSIT

Ms. Lucy-Noll gave a brief overview of the draft TIP, noting that new projects included bus replacements and facility improvements. After a brief discussion, Mr. Rovansek made a motion to approve the draft 2023-2026 TIP for Public Transit as presented. The motion was seconded by Commissioner Smith and passed unanimously.

DISCUSSION ITEMS

RAISE Projects Update: Mr. Imhoff gave an update on implementation of the RAISE grant funding award. Preliminary steps to initiate project management are underway, and the city is working with the Federal Transit Authority (FTA) on funding administration. Mr. Imhoff noted that expectations on the outcome of the projects should be tempered, due to increasing costs since the funding was awarded. Construction is targeted for 2023-2024.

Mr. Prestash reported that Westmont Borough had inquired about installing a traffic signal on PA 271 across from the Westmont Elementary School, in order to make it safer for pedestrians to cross there. Mr. Prestash further explained a study of the area previously concluded that a signal would not be warranted in that location, and recommended a pedestrian crosswalk with push-button flashing signs be installed. PennDOT will meet with the local Police Chief to discuss installation.

OTHER BUSINESS

There being no further business to discuss, the meeting was adjourned.
