The meeting was called to order by Mr. Tom Prestash, PennDOT District 9-0. Mr. Prestash noted that the meeting was being recorded through Microsoft Teams. Mr. Chris Allison, Cambria County Planning Commission, polled the members present.

APPROVAL OF MINUTES OF THE COMBINED MPO TECHNICAL AND COORDINATING COMMITTEES MEETING OF JUNE 29, 2022

The committee members reviewed the meeting minutes. Mr. Tusing made a motion that the minutes be approved. The motion was seconded by Mr. Pioli, and passed unanimously.

APPROVAL OF AMENDMENTS AND MODIFICATIONS TO THE FFY 2023-2026 HIGHWAY AND BRIDGE TIP

Amendment Vote: Highway Safety Improvement Program (HSIP) Projects: Ms. Stich from PennDOT District 9-0, which involved adding federal Infrastructure Investment and Jobs Act (IIJA) funds as a new TIP line item project, and then redistributing funds into the new project. Commissioner Smith made a motion to approve the amendment, which was seconded by Mr. Dubnansky and passed unanimously.

Ms. Stich then reviewed the list of TIP modifications, noting that none of them required a vote. After her presentation, committee members asked a couple of project-related questions:

Mr. Rovansek asked about the status of the Franklin Street corridor project; Mr. Greenland responded that repaving was set to begin on October 10, and that the project should be concluded this construction season. Mr. Ashcom relayed a question from Johnstown City Manager Ethan Imhoff regarding removal of on-street parking along the project corridor. Mr. Allison and Mr. Greenland responded that they did not believe any spaces were to be removed, but Mr. Greenland said he would confirm and follow up. There were also questions raised regarding storm water drainage on Osborne Street, as well as the placement of a fire hydrant at the corner of Osborne and Franklin Streets. Mr. Greenland again agreed to follow up with answers to the questions.

REVIEW AND APPROVAL OF AMENDMENTS AND MODIFICATIONS TO THE FFY 2023-2026 PUBLIC TRANSIT TIP

Ms. Morley said that there were no amendments requiring a vote, but noted that the revised 2022 Transit Asset Management (TAM) Plan would be completed by Friday (9/30/22). She indicated that she would email it to Mr. Allison, who in turn agreed to forward it to the committee members.

DISCUSSION ITEMS

<u>PennDOT Bike-Ped Policy Changes:</u> Mr. Prestash noted two recent changes to statewide bicycle/pedestrian policies: First, any pedestrian crossings constructed by PennDOT will now be required to have a maintenance agreement with a municipality, nonprofits and trail groups will no longer be permitted to own the crossings. The groups will be able to establish a sub-agreement with the municipality for crossing maintenance. The new policy also allows for the PennDOT District office to include Highway Occupancy Permit (HOP) requirements in some circumstances, rather than having to go through a separate HOP process.

<u>PennDOT Project Updates</u>: Mr. Greenland reviewed a few of the larger projects that were nearing completion, including the Franklin Street corridor improvements, PA 403 Somerset County to PA 56 improvement project, which included paving and the addition of a bike lane, and the roundabout project in Geistown at the intersection of Scalp Avenue, Belmont Avenue, and Bedford Street.

OTHER BUSINESS

Mr. Allison noted that the next meeting would be held on December 7, 2022, at the Ebensburg Borough office, starting at 10:00 AM.

There being no further business to discuss, the meeting was adjourned.
